## **General Information**

- **1.** All applications will be made online on the dates announces on our web site. (August 19, 2024 (08.00) August 23, 2024 (17.00)
- **2.** Candidates graduated from institutions abroad must upload the recognition document obtained from the Higher Education Institution (YÖK) to the online application system.
- **3.** If the grade as to 100 grading system is not specified in the transcript received by the graduates of undergraduate and graduate programs who apply to our programs;
  - **a.** A system transformation chart of 100 approved by the relevant institution is accepted.
  - **b.** If the grades given in the transcript according to different systems have a description range according to the 100 system, the lower limit of the range is converted to the 100-grading system by accepting the initial value.
  - **c.** In the absence of the above-mentioned documents, "Grades in the 4-Grading System and in the 100-Grading System Chart" of the Council of Higher Education (YÖK) is used.
  - **d.** Ege University grade transformation table is used for the graduation grades of the candidates applying to graduate programs in the 20- and 5-grading systems.
- **4.** Candidates can simultaneously apply to 2 (two) single-discipline graduate programs, 1 (one) multi-disciplinary graduate program (Women's Studies Master's Program with Thesis and Industrial Design Culture and Practices Master's Program) and 1 (one) non-thesis master's program.
- **5.** If there is a coincidence in the written scientific evaluation and/or interview dates of our candidates who have applied to more than one program, it is important that our candidates contact the relevant Department Heads before the exam day.
- **6.** Complete and correct information declaration is the candidate's responsibility.
- **7.** Applications by mail will not be accepted. Only online applications will be accepted.
